Award: Meritorious Unit Commendation

Period of service: 2 October 2009 to 4 October 2010

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 2 October 2009 to 4 October 2010, the 2d Battalion, 69th Armored Regiment and its subordinate units displayed exceptionally meritorious service in support of Operation Iraqi Freedom. The Battalion demonstrated technical expertise in providing for the stabilization of the Babil and Karbala Provinces. The 2d Battalion, 69th Armored Regiment supported provincial reconstruction teams and Iraqi security forces to ensure the security of the Battalion's area of operations. The Battalion developed a strong relationship with Iraqi Army and police units by conducting joint patrols and raids. This relationship allowed for a quick exchange of time-sensitive intelligence that reduced insurgent activity in both provinces. The 2d Battalion, 69th Armored Regiment supported the provincial reconstruction team's development of the agricultural and economic power base for the two provinces by providing projects injecting over 55,000,000 dollars into local economies. The remarkable proficiency and devotion to duty displayed by Headquarters and Headquarters Company, 2d Battalion, 69th Armored Regiment and its subordinate units are in keeping with the finest traditions of military service and reflects distinct credit upon the unit, United States Division-South and the United States Army.
