Award: Meritorious Unit Commendation Period of service: 5 July 2009 to 28 March 2010. Authority: AR 600-8-22, paragraph 7-15 Reason: For exceptionally meritorious service. During the period 5 July 2009 to 28 March 2010, the Headquarters and Headquarters Detachment, 180th Transportation Battalion and its subordinate units displayed exceptionally meritorious service in support of Operation Iraqi Freedom. The deployment was defined by conducting first rate maintenance, training soldiers above the standard, placing soldier welfare at the forefront of decision making, and by placing mission accomplishment above all else. In total, the 180th Transportation Battalion and its subordinate units provided responsive, tailored and adaptive heavy equipment transport to more than 20 different forward operating bases and covered a distance of more than 64 million convoy miles. Further, monarch convoys hauled over 10,000 pieces of equipment and supplies equating to over 15,000,000 short tons of cargo.
