Award: Valorous Unit Award

Period of service: 1 October 2007 to 1 June 2008

Reason: For extraordinary heroism in action against an armed enemy. During the period 1 October 2007 to 1 June 2008, Headquarters, 3d Special Forces Battalion, 3d Special Forces Group, 1st Special Forces Regiment and its subordinate units exhibited extraordinary gallantry, valor, steadfast determination, professionalism and esprit de corps in an extremely hazardous operational environment during combat operations in Regional Command East, Afghanistan. 
