Award: Meritorious Unit Commendation

Period of service: 17 December 2007 to 15 September 2008.

Authority: AR 600-8-22, paragraph 7-15


Reason: For exceptionally meritorious service. During the period 17 December 2007 to 15 September 2008, Headquarters and Headquarters Company, 300th Military Police Brigade and its subordinate units displayed exceptionally meritorious service in support of Operation Iraqi Freedom. The unit synchronized and executed the full spectrum of detention operations throughout the Iraqi theater of operations, providing safe control, custody and reconciliation of over 20,000 detainees. The unit was instrumental in supporting the adjudication process of a record number of insurgents and worked fervently to ensure terrorists were convicted in accordance with Iraqi law, thereby removing them as a threat to the Iraqi people and Coalition Forces. The Brigade's efforts to strengthen and support the rule of law in Iraq enabled the emerging Iraqi government to more actively participate in the processing, release and rehabilitation of detainees, thus returning them as more productive members of Iraqi society. Headquarters and Headquarters Company, 300th Military Police Brigade and its subordinate units were instrumental in conducting the transfer of detention operations to the government of Iraq by developing and managing a transition plan that included the training of over 300 Iraqi correctional officers and vastly improving Iraq's correctional infrastructure. Headquarters and Headquarters Company, 300th Military Police Brigade and its subordinate units' outstanding performance reflects great credit upon the unit, Multi-National Force-Iraq and the United States Army.
