Award: Meritorious Unit Commendation

Period of service: 30 January 2013 to 30 October 2013

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 30 January 2013 to 30 October 2013, the 635th Transportation Detachment displayed exceptionally meritorious service in support of Operation Enduring Freedom. The unit operated the arrival/departure Aerial Control Group Yard and the Joint Distribution Management Center at Bagram Airfield, the Rotary Passenger Terminal and Army Combined Air Terminal Operations Yard at Kabul International Airport and the Rotary Passenger Terminal at Camp Phoenix. The unit processed over 167,300 short tons of cargo, created over 8,000 transportation movement requests, coordinated and tracked over 443,000 passengers in both fixed wing and rotary modes, processed over 4,800 air movement requests and loaded over \$20 million worth of humanitarian goods. The 635th Transportation Detachment's mission execution and commitment to excellence set a new standard for ground and air operations on three Forward Operating Bases. The actions of 635th Transportation Detachment are in keeping with the highest military traditions and reflect great credit upon itself, the 39th Joint Movement Control Battalion, the 1st Sustainment Command (Theater) and the United States Army.

The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned. It is not the responsibility of HRC to replace streamers that are lost or damaged. Please refer to AR 840-10 for further guidance regarding the responsibilities of the unit concerning the display, care and disposition of the streamers.
