Reason: For extraordinary heroism in action against an armed enemy. During the period 18 June 2011 to 14 May 2012, Headquarters, 2d Brigade Combat Team, 4th Infantry Division and the cited units distinguished themselves with extraordinary heroism while engaged in military operations against an armed enemy. While conducting combat and stability operations across two regional commands to include several districts around Kandahar City, Badghis, Herat and Farah Provinces, in Western and Southern Afghanistan the members of the brigade aggressively conducted clearing operations to remove a determined and prepared enemy force. These efforts are a testament to the professionalism and determination of the Soldiers, Sailors, Airmen and Afghan National Security Forces. The aftermath of these operations has created an environment where the people believe they live in a safe environment led by competent leaders of government and secured by effective and legitimate security forces. It is not the responsibility of HRC to replace streamers that are lost or damaged.
