

Department of the army Lineage and Honors

4th BATTALION, 6th INFANTRY REGIMENT

Constituted 11 January 1812 in the Regular Army as a company of the 11th Infantry

Organized March–May 1812 in Vermont, New Hampshire, or Connecticut

Consolidated May–October 1815 with a company of the 25th Infantry (constituted 26 June 1812) and a company each of the 27th, 29th, and 37th Infantry (all constituted 29 January 1813) to form a company of the 6th Infantry

Designated 22 May 1816 as Company D, 6th Infantry

Consolidated 1 May 1869 with Company D, 42d Infantry, Veteran Reserve Corps (constituted 21 September 1866), and consolidated unit designated as Company D, 6th Infantry

(6th Infantry assigned 18 November 1917 to the 5th Division; relieved in August 1921 from assignment to the 5th Division; assigned 24 March 1923 to the 6th Division; relieved 16 October 1939 from assignment to the 6th Division)

Reorganized 15 July 1940 as Company D, 6th Infantry (Armored), an element of the 1st Armored Division

Redesignated 1 January 1942 as Company D, 6th Armored Infantry, an element of the 1st Armored Division

Reorganized and redesignated 20 July 1944 as Company A, 11th Armored Infantry Battalion, an element of the 1st Armored Division

Converted and redesignated 1 May 1946 as Troop A, 11th Constabulary Squadron, an element of the 1st Constabulary Regiment

Inactivated 20 September 1947 in Germany

Converted and redesignated 7 April 1949 as Company A, 11th Armored Infantry Battalion (11th Constabulary Squadron concurrently relieved from assignment to the 1st Constabulary Regiment)

Redesignated 10 October 1950 as Company D, 6th Infantry

Activated 16 October 1950 in Germany

Inactivated 1 June 1958 in Germany

Redesignated 11 May 1959 as Headquarters and Headquarters Company, 4th Battle Group, 6th Infantry, withdrawn from the Regular Army, allotted to the Army Reserve, and assigned to the 102d Infantry Division (organic elements concurrently constituted)

Battle Group activated 1 June 1959 with Headquarters at St. Louis, Missouri (Headquarters and Headquarters Company concurrently consolidated with Headquarters and Headquarters Company, 407th Infantry [see ANNEX], and consolidated unit designated as Headquarters and Headquarters Company, 4th Battle Group, 6th Infantry)

Reorganized and redesignated 1 April 1963 as the 4th Battalion, 6th Infantry

Inactivated 31 December 1965 at St. Louis, Missouri

Withdrawn 13 September 1972 from the Army Reserve, allotted to the Regular Army, relieved from assignment to the 102d Infantry Division, and assigned to the United States Army Berlin Brigade; concurrently activated in Germany

Inactivated 29 June 1984 in Germany, and relieved from assignment to the Berlin Brigade

Assigned 1 August 1984 to the 5th Infantry Division and activated at Fort Polk, Louisiana

Inactivated 16 December 1992 at Fort Polk, Louisiana, and relieved from assignment to the 5th Infantry Division

Redesignated 1 October 2005 as the 4th Battalion, 6th Infantry Regiment

Assigned 16 March 2008 to the 4th Brigade Combat Team, 1st Armored Division, and activated at Fort Bliss, Texas

ANNEX

Constituted 23 July 1918 in the National Army as Headquarters and Headquarters Company, 407th Infantry, an element of the 102d Division

Demobilized 30 November 1918

Reconstituted 24 June 1921 in the Organized Reserves as an element of the 102d Division (later redesignated as the 102d Infantry Division)

Organized in November 1921 at St. Louis, Missouri

Ordered into active military service 15 September 1942 and reorganized at Camp Maxey, Texas

Inactivated 16 March 1946 at Camp Kilmer, New Jersey

Activated 7 April 1947 in the Organized Reserves at Danville, Illinois

Location changed 15 March 1948 to St. Louis, Missouri

(Organized Reserves redesignated 25 March 1948 as the Organized Reserve Corps; redesignated 9 July 1952 as the Army Reserve)

Consolidated 1 June 1959 with Headquarters and Headquarters Company, 4th Battle Group, 6th Infantry, and consolidated unit designated as Headquarters and Headquarters Company, 4th Battle Group, 6th Infantry (remainder of the 407th Infantry inactivated)
