Inactivated 16 November 1987 in Germany, and relieved from assignment to the 1st Armored Division

Redesignated 2 October 1988 as Headquarters and Headquarters Company, 2d Battalion, 10th Aviation

Assigned 16 March 1996 to the 10th Mountain Division and activated at Fort Drum, New York (organic elements concurrently constituted and activated)

Battalion relieved 19 September 2005 from assignment to the 10th Mountain Division and assigned to the Combat Aviation Brigade, 10th Mountain Division

Redesignated 1 October 2005 as 2d Battalion, 10th Aviation Regiment
