<b>OCMO: Pentagon Tenants COVID-19 Reporting Requirements (6 Apr 20)</b>	<ul style="list-style-type: none"> <li>● Pentagon reservation tenants must report suspected exposure/positive test results for COVID-19 as well as recovery and return-to-work status.</li> <li>● Reports should be sent encrypted to <a href="mailto:pfpa.oem.covid19@mail.mil">pfpa.oem.covid19@mail.mil</a> in an attached format.</li> </ul>
<b>OCMO: Pentagon Reservation Cloth Face Covering Requirement (7 Apr 20)</b>	<ul style="list-style-type: none"> <li>● All people entering the Pentagon in open public spaces and work spaces where it's difficult to maintain 6 feet of social distance must wear cloth face coverings.</li> <li>● Food prep/concession retailers must wear cloth face coverings.</li> <li>● Cleaning crews must wear PPE.</li> <li>● In the interim, individuals are encouraged to wear household items to cover their nose/mouth.</li> <li>● Those unable to wear face coverings should notify their CDR/Supervisor until an ETP is acted upon.</li> <li>● O-6/GS-15 are ETP authorities.</li> </ul>
