Organized and Federally recognized 1 September 1978 in the Florida Army National Guard at Jacksonville as Company D, 26th Aviation Battalion, an element of the 26th Infantry Division

Expanded, reorganized, and redesignated 2 October 1986 as the 419th Aviation Battalion and relieved from assignment to the 26th Infantry Division

Reorganized and redesignated 1 October 1987 as the 111th Aviation, a parent regiment under the United States Army Regimental System, to consist of the 1st Battalion

Reorganized 1 September 1996 in the Florida and Vermont Army National Guard to consist of the 1st Battalion and Company E

(Company E ordered into active Federal service 3 March 2003 at Jacksonville; released 1 March 2004 from active Federal service and reverted to state control)

(Company E ordered into active Federal service 20 June 2005 at Starke)

Reorganized and redesignated 1 October 2005 in the Florida, Arkansas, Mississippi, and Puerto Rico Army National Guard as the 111th Aviation Regiment, to consist of the 1st Battalion and Company E

(Company E released from active Federal service 16 December 2006 and reverted to state control)

(1st Battalion ordered into active Federal service 1 June 2006; released from active Federal service 27 November 2007 and reverted to state control)

Reorganized 16 October 2007 in the Florida, Arkansas, Mississippi, and Puerto Rico Army National Guard to consist of the 1st and 2d Battalions

(2d Battalion ordered into active Federal service 27 May 2009 at Starke; released from active Federal service 30 June 2010 and reverted to state control)

(1st Battalion ordered into active Federal service 28 August 2011 at home stations; released from active Federal service 30 September 2012 and reverted to state control)

(2d Battalion ordered into active Federal service 11 July 2013 at home stations; released from active Federal service 14 August 2014 and reverted to state control)

(1st Battalion ordered into active Federal service 2 June 2016 at home stations; released from active Federal service 6 July 2017 and reverted to state control)
