407th CIVIL AFFAIRS BATTALION

Constituted 10 January 1949 in the Organized Reserve Corps as the 407th Military Government Company

Activated 1 February 1949 at St. Paul, Minnesota

Location changed 5 November 1951 to Fort Snelling, Minnesota

(Organized Reserves redesignated 25 March 1948 as the Organized Reserve Corps; redesignated 9 July 1952 as the Army Reserve)

Reorganized and redesignated 3 August 1956 as the 407th Civil Affairs and Military Government Company

Redesignated 23 November 1959 as the 407th Civil Affairs Company

Detachment ordered into active military service 11 December 1990 at Fort Snelling, Minnesota; remainder of company ordered into active military service 27 December 1990 at Fort Snelling, Minnesota

Company released from active military service 22 April 1991 and reverted to reserve status

Reorganized and redesignated 16 September 1992 as Headquarters and Headquarters Detachment, 407th Civil Affairs Battalion (organic elements concurrently constituted and activated)

Location of Headquarters changed 5 May 1997 to Arden Hills, Minnesota

Ordered into active military service 1 June 2003 at Arden Hills, Minnesota; released from active military service 30 May 2004 and reverted to reserve status

Companies A and B ordered into active military service 1 November 2004 at Arden Hills, Minnesota; released from active military service 31 October 2006 and reverted to reserve status

Companies A and B ordered into active military service 26 November 2007 at Arden Hills, Minnesota; released from active military service 29 December 2008 and reverted to reserve status

Company C ordered into active military service 2 January 2011 at Arden Hills, Minnesota; released from active military service 5 February 2012 and reverted to reserve status

Company B ordered into active military service 18 October 2013 at Arden Hills, Minnesota; released from active military service 21 November 2014 and reverted to reserve status

Company C ordered into active military service 1 June 2014 at Arden Hills, Minnesota; released from active military service 5 July 2015 and reverted to reserve status

Company A ordered into active military service 3 November 2017 at Arden Hills, Minnesota; released from active military service 7 December 2018 and reverted to reserve status

Company B ordered into active military service 7 February 2019 at Arden Hills, Minnesota; released from active military service 6 February 2020 and reverted to reserve status
