Constituted 5 July 1946 in the Georgia National Guard as Battery C, 101st Antiaircraft Automatic Weapons Battalion

Organized and Federally recognized 18 December 1947 at Swainsboro

Reorganized and redesignated 1 July 1959 as Battery C, 2d Gun Battalion, 214th Artillery

Converted and redesignated 1 May 1962 as Company B, 5th Medium Tank Battalion, 108th Armor, an element of the 48th Armored Division

Converted and redesignated 16 April 1963 as Company B, 3d Battalion, 121st Infantry, an element of the 48th Armored Division

Converted redesignated 1 January 1968 as Company A, 878th Engineer Battalion, and relieved from assignment to the 48th Armored Division

Reorganized and redesignated 1 October 1976 as Company D, 878th Engineer Battalion

Reorganized and redesignated 1 December 1988 as Company A, 878th Engineer Battalion

Ordered into active Federal service 15 March 2003 at Swainsboro; released from active Federal service 3 August 2004 and reverted to state control

Ordered into active Federal service 22 September 2005 at Swainsboro; released from active Federal service 28 January 2007 and reverted to state control

Consolidated 1 September 2007 with Detachment 1, Company A, 878th Engineer Battalion (see ANNEX 1), and Company C, 878th Engineer Battalion (see ANNEX 2), and consolidated unit designated as the 810th Engineer Company

Ordered into active Federal service 18 September 2009 at Swainsboro; released from active Federal service 22 October 2010 and reverted to state control

Converted and redesignated 1 January 1968 as the 2d General Construction Platoon, Company C, 878th Engineer Battalion, and relieved from assignment to the 48th Armored Division

Reorganized and redesignated 1 December 1971 as Detachment 1, Company C, 878th Engineer Battalion

Reorganized and redesignated 1 December 1973 as Company B, 878th Engineer Battalion

Reorganized and redesignated 1 April 1996 as Detachment 1, Company A, 878th Engineer Battalion

Ordered into active Federal service 15 March 2003 at Swainsboro; released from active Federal service 3 August 2004 and reverted to state control

Ordered into active Federal service 22 September 2005 at Swainsboro; released from active Federal service 28 January 2007 and reverted to state control
