**7th FINANCE DETACHMENT**

Parent unit organized 25 May 1917 in the New York National Guard at New York as Headquarters Troop, New York Division

Called into Federal service 24 July 1917 at New York; drafted into Federal service 5 August 1917

Reorganized and redesignated 1 October 1917 as Headquarters Troop, 27th Division

Demobilized 1 April 1919 at Camp Upton, New York

Consolidated 15 November 1921 with Company A, 1st Machine Gun Battalion, New York Guard (see ANNEX 1), and consolidated unit reorganized and Federally recognized in the New York National Guard at New York as Headquarters Company, Special Troops, 27th Division

Reorganized and redesignated 27 October 1937 as Headquarters Company, 27th Division (later redesignated as the 27th Infantry Division)

Inducted into Federal service 15 October 1940 at New York

Reorganized and redesignated 1 September 1942 as Headquarters Company (less Military Police Platoon), 27th Infantry Division

Inactivated 31 December 1945 at Fort Lawton, Washington

Consolidated 27 September 1946 with Headquarters Company (less Military Police Platoon), 42d Infantry Division (see ANNEX 2) and consolidated unit designated as Headquarters Company, 42d Infantry Division

## **7th FINANCE DETACHMENT**

Reorganized and Federally recognized 20 June 1947 in the New York National Guard at New York

Converted, reorganized, and redesignated 19 May 1959 as the 42d Administration Company and remained assigned to the 42d Infantry Division

Ordered into active Federal service 24 March 1970 at New York; released from active Federal service 30 March 1970 and reverted to state control

Redesignated 1 October 1971 as the 42d Adjutant General Company

Reorganized and redesignated 1 September 1990 as Detachment 1, 42d Adjutant General Company

Expanded, converted, reorganized, and redesignated 1 October 1993 as the 7th and 37th Finance Detachments (37th Finance Detachment-hereafter separate lineage)

7th Finance Detachment ordered into active Federal service 10 February 2003 at New York; released from active Federal service 1 December 2003 and reverted to state control

Ordered into active Federal service 10 June 2006 at New York; released from active Federal service 3 December 2007 and reverted to state control

### **ANNEX 1**

Organized 29 July 1918 in the New York Guard at New York as the Motor Machine Gun Battery, 1st Field Artillery

Reorganized and redesignated 23 May 1919 as the 1st Motor Machine Gun Company

Reorganized and redesignated 3 November 1919 as Company A, 1st Machine Gun Battalion

### **ANNEX 2**

Constituted 5 February 1943 in the Army of the United States as Headquarters Company (less Military Police Platoon), 42d Infantry Division

Activated 14 July 1943 at Camp Gruber, Oklahoma

Inactivated 13 July 1946 in Austria

Allotted 17 September 1946 to the New York National Guard


