*Lineage and Honors*

**110th INFANTRY REGIMENT  
(FIGHTING TENTH)**

Organized 28 November 1873 in the Pennsylvania National Guard from existing units in southwestern Pennsylvania as the 10th Infantry Regiment

Mustered into Federal service 11-12 May 1898 at Mount Gretna as the 10th Pennsylvania Volunteer Infantry; mustered out of Federal service 22 August 1899 at San Francisco, California

Reorganized in 1900 in southwestern Pennsylvania as the 10th Infantry Regiment

Mustered into Federal service 2 July 1916 at Mount Gretna; mustered out of Federal service 25 October- 1 November 1916

Drafted into Federal service 5 August 1917

Consolidated 11 October 1917 with the 3d Infantry Regiment (organized in 1747), Pennsylvania National Guard; consolidated unit concurrently reorganized and redesignated as the 110th Infantry and assigned to the 28th Division

Demobilized 24 May 1919 at Camp Dix, New Jersey

Former 10th Infantry Regiment reorganized 1919-1920 in the Pennsylvania National Guard in southwestern Pennsylvania as the 10th Infantry; Headquarters Federally recognized 29 July 1920 at Washington (former 3d Infantry – hereafter separate lineage)

Redesignated 1 April 1921 as the 110th Infantry and assigned to the 28th Division (later redesignated as the 28th Infantry Division)

Inducted into Federal service 17 February 1941 at home stations

## **110th INFANTRY REGIMENT (FIGHTING TENTH)**

Inactivated 25 October 1945 at Camp Shelby, Mississippi

Reorganized and Federally recognized 12 December 1946 with Headquarters at Washington

Ordered into active Federal service 5 September 1950 at home stations

(110th Infantry [NGUS] organized and Federally recognized 16 July 1953 with Headquarters at Washington)

Released 15 June 1954 from active Federal service and reverted to state control; Federal recognition concurrently withdrawn from the 110th Infantry (NGUS)

Reorganized 1 June 1959 as a parent regiment under the Combat Arms Regimental System, to consist of the 1st Battle Group, an element of the 28th Infantry Division

Reorganized 1 April 1963 to consist of the 1st Battalion, an element of the 28th Infantry Division

Reorganized 17 February 1968 to consist of the 1st Battalion, an element of the 42d Infantry Division

Reorganized 1 April 1975 to consist of the 1st and 2d Battalions, elements of the 28th Infantry Division

Withdrawn 5 April 1988 from the Combat Arms Regimental System and reorganized under the United States Army Regimental System

Reorganized 1 September 1995 to consist of the 1st Battalion, an element of the 28th Infantry Division

Reorganized 1 September 2002 to consist of the 1st Battalion, an element of the 2d Brigade Combat Team, 28th Infantry Division, with Headquarters at Mt. Pleasant

Ordered into active Federal service 19 January 2005 at home stations

Redesignated 1 October 2005 as the 110th Infantry Regiment

Released from active Federal service 1 October 2006 and reverted to state control

Companies C and D ordered into active Federal service 3 January 2010 at home stations; released from active Federal service 6 February 2011 and reverted to state control

Ordered into active Federal service 11 May 2016 at home stations; Released from active Federal service 14 June 2017 and reverted to state control
