**120th MEDICAL COMPANY**

Organized and Federally recognized 3 September 1918 in the Oklahoma National Guard at Tulsa as Company B, 3d Infantry

Reorganized and redesignated 2 June 1921 as Headquarters Company, 1st Battalion, 3d Infantry

Redesignated 14 October 1921 as Headquarters Company, 1st Battalion, 180th Infantry, an element of the 45th Division (later redesignated as the 45th Infantry Division)

Reorganized and redesignated 31 December 1921 as Company L, 180th Infantry

Inducted into Federal service 16 September 1940 at Tulsa

Inactivated 24 November 1945 at Camp Bowie, Texas

Reorganized and Federally recognized 6 March 1947 in the Oklahoma National Guard at Tulsa as Company F, 279th Infantry, an element of the 45th Infantry Division

Ordered into active Federal service 1 September 1950 at Tulsa (Company F, 279th Infantry [NGUS], organized and Federally recognized 8 December 1952 at Tulsa)

Released 30 April 1954 from active Federal service and reverted to state control; Federal recognition concurrently withdrawn from Company F, 279th Infantry (NGUS)

Reorganized and redesignated 1 May 1959 as Company A, 2d Battle Group, 179th Infantry, an element of the 45th Infantry Division

Converted, reorganized, and redesignated 1 April 1963 as Company D, 120th Medical Battalion, an element of the 45th Infantry Division

## **120th MEDICAL COMPANY**

Reorganized and redesignated 1 February 1968 as the 145th Medical Company and relieved from assignment to the 45th Infantry Division

Location changed 1 December 1971 to Sperry; on 1 May 1982 to Broken Arrow

Ordered into active Federal service 21 November 1990 at Broken Arrow; released from active Federal service 16 May 1991 and reverted to state control

Reorganized and redesignated 1 September 1995 as Company B, 111th Medical Battalion

Ordered into active Federal service 21 March 2003 at Broken Arrow; released from active Federal service 20 March 2004 and reverted to state control

Reorganized and redesignated 1 September 2007 as the 120th Medical Company

Ordered into active Federal service 4 October 2010 at Broken Arrow


