**1138th MILITARY POLICE COMPANY**

Mustered into the Missouri National Guard 31 October 1899 at West Plains as Company K, 2d Infantry

Redesignated 23 January 1908 as Company A, 6th Infantry

Redesignated 9 July 1914 as Company D, 2d Infantry

Called into Federal service 18 June 1916

Mustered into Federal service 28 June 1916 at Nevada; mustered out of Federal service 13 January 1917 at Fort Riley, Kansas

Drafted into Federal service 5 August 1917

Reorganized and redesignated 1 October 1917 as Company D, 128th Machine Gun Battalion, an element of the 35th Division

Redesignated 1 March 1918 as Company D, 130th Machine Gun Battalion, an element of the 35th Division

Demobilized 7 May 1919 at Fort Riley, Kansas

Reorganized and Federally recognized 16 November 1920 in the Missouri National Guard at West Plains as Company D, 1st Infantry

Redesignated 31 March 1921 as Company D, 6th Infantry

Redesignated 1 October 1921 as Company D, 140th Infantry, an element of the 35th Division (later redesignated as the 35th Infantry Division)

## **1138th MILITARY POLICE COMPANY**

Reorganized and redesignated 1 July 1930 as the Howitzer Company, 140th Infantry

Reorganized and redesignated 1 October 1939 as the Antitank Platoon, Headquarters Company, 140th Infantry

Reorganized and redesignated 9 December 1940 as the Antitank Company, 140th Infantry

Inducted into Federal service 23 December 1940 at West Plains

(140th Infantry relieved 27 January 1943 from assignment to the 35th Infantry Division)

Inactivated 20 September 1945 at Camp Rucker, Alabama

(140th Infantry assigned 20 June 1946 to the 35th Infantry Division)

Reorganized and Federally recognized 29 May 1947 at West Plains as Company M, 140th Infantry

Reorganized and redesignated 15 April 1959 as the Rifle and Weapons Platoon, Company E, 2d Battle Group, 140th Infantry

Converted and redesignated 1 April 1963 as the 202d Engineer Company, and relieved from assignment to the 35th Infantry Division

Converted and redesignated 15 January 1968 as the 1138th Military Police Company

Ordered into active Federal service 15 November 1990 at West Plains; released from active Federal service 4 May 1991 and reverted to state control

Ordered into active Federal service 1 October 2001 at West Plains; released 10 February 2003 and reverted to state control

Ordered into active Federal service 10 February 2003 at West Plains, released from active Federal service 9 February 2004 and reverted to state control

Ordered into active Federal service 24 June 2009 at West Plains; released from active Federal service 28 July 2010 and reverted to state control
