200th MILITARY POLICE COMPANY

Organized and Federally recognized 8 May 1923 in the Maryland National Guard at Pocomoke City as Headquarters Company, 3d Battalion, 1st Infantry, an element of the 29th Division

Redesignated 1 May 1940 as Headquarters Detachment, 3d Battalion, 1st Infantry

Redesignated 1 January 1941 as Headquarters Detachment, 3d Battalion, 115th Infantry

Redesignated 14 September 1942 as Headquarters Company, 3d Battalion, 115th Infantry, an element of the 29th Infantry Division

Inducted into Federal service 3 February 1941 at Pocomoke City

Inactivated 17 January 1946 at Camp Kilmer, New Jersey

Reorganized and Federally recognized 10 July 1947 at Pocomoke City as Company M, 115th Infantry

Reorganized and redesignated 1 March 1959 as the Rifle and Weapons Platoons, Company A, 2d Battle Group, 115th Infantry

Reorganized and redesignated 1 March 1963 as Company A, 2d Battalion, 115th Infantry

Reorganized and redesignated 1 March 1964 as two Rifle Platoons, Company A, 2d Battalion, 115th Infantry

Reorganized and redesignated 1 November 1965 as the Weapons Platoon, Company A, 2d Battalion, 115th Infantry

200th MILITARY POLICE COMPANY

Converted and redesignated 21 January 1968 as the 1st Military Police Guard Platoon, 200th Military Police Company and relieved from assignment to the 29th Infantry Division

Consolidated 1 April 1970 with the 200th Military Police Company (organized and Federally recognized 21 January 1968 at Salisbury) and consolidated unit designated as the 200th Military Police Company and location changed to Salisbury

Ordered into active Federal service 15 November 1990 at Salisbury; released 5 June 1991 from active Federal service and reverted to state control

Ordered into active Federal service 1 October 2001 at Salisbury; released from active Federal service 30 September 2002 and reverted to state control

Location changed 1 September 2006 to Catonsville

Ordered into active Federal service 28 April 2013 at Salisbury; released from active Federal service 1 June 2014 and reverted to state control

Location changed 1 January 2023 to Sykesville
