**755th MILITARY POLICE COMPANY**

Organized and Federally recognized 14 March 1920 in the Puerto Rico National Guard at Arecibo as Company I, 1st Regiment of Infantry

Redesignated 1 June 1921 as Company M, 1st Regiment of Infantry

Redesignated 23 January 1923 as Company M, 295th Infantry

Redesignated 25 October 1923 as Company D, 296th Infantry

Redesignated 1 June 1936 as Company D, 295th Infantry

Inducted into Federal service 15 October 1940 at Camp Tortuguero, Puerto Rico

Inactivated 20 February 1946 in the Canal Zone

Reorganized and Federally recognized 5 January 1947 at Arecibo as Company H, 295th Infantry

Reorganized and redesignated 15 February 1959 as Company E, 1st Battle Group, 65th Infantry

Reorganized and redesignated 1 July 1961 as Company E, 1st Battle Group, 295th Infantry

(1st Battle Group, 295th Infantry, assigned 1 May 1963 to the 92d Infantry Brigade)

Reorganized and redesignated 1 May 1964 as Company C, 2d Battalion, 295th Infantry, and relieved from assignment to the 92d Infantry Brigade

## **755th MILITARY POLICE COMPANY**

Consolidated 31 December 1967 with Company B, 2d Battalion, 295th Infantry (see ANNEX) and consolidated unit converted, reorganized, and redesignated as Company C, 124th Military Police Battalion

Reorganized and redesignated 1 March 1972 as the 755th Military Police Company

Ordered into active Federal service 3 January 1991 at Arecibo; released from active Federal service 22 June 1991 and reverted to territorial control

Ordered into active Federal service 4 May 2000 at Arecibo; released from active Federal service 5 January 2001 and reverted to territorial control

Ordered into active Federal service 17 January 2003 at Arecibo; released from active Federal service 27 June 2004 and reverted to territorial control

Organized and Federally recognized 18 March 1954 at Arecibo as Company H, 296th Infantry (NGUS)

Reorganized and redesignated 19 November 1954 as Company H, 296th Infantry

Reorganized and redesignated 15 February 1959 as Company D, 1st Battle Group, 295th Infantry

Reorganized and redesignated 1 July 1961 as Company C, 1st Battle Group, 295th Infantry

(1st Battle Group, 295th Infantry, assigned 1 May 1963 to the 92d Infantry Brigade)

Reorganized and redesignated 1 May 1964 as Company B, 2d Battalion, 295th Infantry, and relieved from assignment to the 92d Infantry Brigade
