Ordered into active Federal service 11 November 1990 at home stations; released 10 April 1991 from active Federal service and reverted to state control

Ordered into active Federal service 3 January 2005 at home stations, released from active Federal service 1 July 2006 and reverted to state control

Ordered into active Federal service 21 April 2009 at home stations; released from active Federal service 25 May 2010 and reverted to state control
