Organized 1 August 1985 from new and existing units in the Vermont Army National Guard as the 186th Support Battalion and assigned to the 50th Armored Division; Headquarters organized and Federally recognized 10 June 1986 at Northfield

Relieved 1 June 1988 from assignment to the 50th Armored Division and assigned to the 26th Infantry Division

Relieved 1 September 1993 from assignment to the 26th Infantry Division and assigned to the 42d Infantry Division

Location of Headquarters changed to 1 May 2003 to Montpelier

Reorganized 1 September 2007 in the Vermont, Connecticut, Maine, and New Hampshire Army National Guard; concurrently, relieved from assignment to the 42d Infantry Division, and assigned to the 86th Infantry Brigade Combat Team

Reorganized 1 September 2008 in the Vermont, Maine, Massachusetts, and New Hampshire Army National Guard, and remained assigned to the 86th Infantry Brigade Combat Team; concurrently, location of Headquarters changed to Northfield

Ordered into active Federal service 18 November 2009 at home stations; released from active Federal service 22 December 2010 and reverted to state control

Reorganized 31 December 2018 in the Vermont, Colorado, Connecticut, Maine, Massachusetts, and New Hampshire Army National Guard, and remained assigned to the 86th Infantry Brigade Combat Team
