Lineage and Honors

**237th SUPPORT BATTALION
(NINTH OHIO)**

Organized 18 July 1881 in the Ohio National Guard from existing units as the 9th Battalion of Infantry

Mustered into Federal service 14 May 1898 at Columbus as the 9th Battalion, Ohio Volunteer Infantry; mustered out of Federal service 28 January 1899 at Camp Marion, South Carolina

Reorganized 14 July 1899 as the 9th Battalion of Infantry

Drafted into Federal service 5 August 1917

Reorganized and redesignated 1 January 1918 as the 2d Battalion, 372d Infantry, an element of the 186th Infantry Brigade

186th Infantry Brigade assigned 5 January 1918 to the 93d Division (Provisional)

Relieved 8 May 1918 from assignment to the 93d Division (Provisional)

Assigned 21 June 1918 to the French 35th Division

Relieved 2 July 1918 from assignment to the French 35th Division and assigned to the French 157th Division; relieved 20 December 1918 from assignment to the French 157th Division

Demobilized 6 March 1919 at Camp Sherman, Ohio

Reorganized 22 September 1924 in the Ohio National Guard as the 1st Separate Battalion, Infantry, with Headquarters at Columbus

237th SUPPORT BATTALION (NINTH OHIO)

Redesignated 1 April 1925 as the 2d Battalion, 372d Infantry

Inducted into Federal service 10 March 1941 at home station

Inactivated 31 January 1946 at Schofield Barracks, Hawaii

Reorganized and Federally recognized 14 October 1948 in the Ohio Army National Guard as the 372d Infantry Battalion, with Headquarters at Cleveland

Battalion broken up 1 September 1959 and its elements reorganized and redesignated as follows:

Headquarters, Headquarters and Service Company as Headquarters and Headquarters Detachment, 38th Ordnance Battalion

(Companies A and B as the 493d and 494th Ordnance Companies; Company C as the 3582d Transportation Company [part]; and Company D as the 3660th Ordnance Company – hereafter separate lineages)

Headquarters and Headquarters Detachment, 38th Ordnance Battalion, consolidated 1 March 1961 with Headquarters and Headquarters Detachment, 37th Ordnance Battalion (see ANNEX 1), and consolidated unit designated as Headquarters and Headquarters Detachment, 37th Ordnance Battalion

Reorganized and redesignated 15 February 1968 as the 115th Light Maintenance Company

Consolidated 1 May 1968 with Headquarters and Headquarters Troop, 1st Reconnaissance Squadron, 107th Armored Cavalry (see ANNEX 2), and consolidated unit designated as the 115th Light Maintenance Company

Redesignated 1 August 1969 as the 155th Light Maintenance Company

Redesignated 1 February 1972 as the 155th Maintenance Company

Consolidated 1 September 1974 with the 194th Engineer Company (see ANNEX 3) and consolidated unit reorganized and redesignated as the 155th Maintenance Company; concurrently, location changed to Willoughby

Consolidated 1 February 1987 with Detachment 1, 155th Maintenance Company (see ANNEX 4), and consolidated unit designated as the 155th Maintenance Company

237th SUPPORT BATTALION (NINTH OHIO)

Redesignated 1 September 1989 as the 372d Maintenance Company

Consolidated 31 March 1994 with the 214th Maintenance Company (organized and Federally recognized 6 December 1993 at Willoughby) and consolidated unit designated as the 372d Maintenance Company

Consolidated 1 April 1998 with Detachment 1, 372d Maintenance Company (organized 7 December 1993 at Medina) and consolidated unit designated as the 372d Maintenance Company; concurrently, location changed to Cleveland

Ordered into active Federal service 25 January 2003 at Cleveland; released from active Federal service 17 August 2003-24 January 2004 and reverted to state control

Expanded, reorganized, and redesignated 1 September 2007 in the Ohio and Michigan Army National Guard as the 237th Support Battalion, with Headquarters at Cleveland, an element of the 37th Infantry Brigade Combat Team

Ordered into active Federal service 3 January 2008 at home stations; released from active Federal service 9 January 2009 and reverted to state control

Ordered into active Federal service 11 September-17 October 2011 at home stations; released from active Federal service 14 October-19 November 2012 and reverted to state control

Reorganized 1 September 2018 in the Ohio, Michigan, and South Carolina Army National Guard, with Headquarters at Cleveland, an element of the 37th Infantry Brigade Combat Tea

Ordered into active Federal service 23 September 2022 at home stations; released from active Federal service 27 October 2023 and reverted to state control

ANNEX 1

Constituted 24 March 1942 in the Army of the United States as Headquarters and Headquarters Detachment, 13th Ordnance Battalion

Activated 25 May 1942 at Fort Sam Houston, Texas

Inactivated 13 March 1946 in England

Redesignated 14 August 1946 as Headquarters and Headquarters Detachment, 37th Ordnance Battalion, and allotted to the Ohio National Guard

237th SUPPORT BATTALION (NINTH OHIO)

Organized and Federally recognized 13 November 1947 in the Ohio National Guard at Cleveland

Ordered into active Federal service 19 August 1950 at Cleveland

(Headquarters and Headquarters Detachment, 37th Ordnance Battalion [NGUS], organized and Federally recognized 30 November 1953 at Cleveland)

Released 3 December 1954 from active Federal service and reverted to state control; Federal recognition concurrently withdrawn from Headquarters and Headquarters Detachment, 37th Ordnance Battalion (NGUS)

ANNEX 2

Organized 10 September 1887 in the Ohio National Guard at Cleveland as the 1st Cleveland Troop (constituted 10 October 1877 as an independent Militia company)

Reorganized and redesignated 3 May 1898 as Troop A, 1st Ohio Volunteer Cavalry

Mustered into Federal service 9 May 1898 at Camp Bushnell, Ohio; mustered out of Federal service 22 October 1898 at Cleveland

Reorganized 14 April 1899 in the Ohio National Guard at Cleveland as Troop A (1st Cleveland Troop)

Redesignated 25 July 1910 as Troop A, 1st Cavalry Squadron

Mustered into Federal service 6 July 1916 at Columbus; mustered out of Federal service 28 February 1917 at Fort Benjamin Harrison, Indiana

Reorganized and redesignated 16 April 1917 as Troop A, 1st Cavalry

Converted and redesignated 23 May 1917 as Battery A, 2d Field Artillery

Mustered into Federal service 15 July 1917 at Cleveland

Drafted into Federal service 5 August 1917

Reorganized and redesignated 15 September 1917 as Battery A, 135th Field Artillery, an element of the 37th Division

Demobilized 10 April 1919 at Camp Sherman, Ohio

237th SUPPORT BATTALION (NINTH OHIO)

Reorganized and Federally recognized 25 October 1920 in the Ohio National Guard at Cleveland as Troop A, 1st Cavalry

Redesignated 1 July 1921 as Troop A, 107th Cavalry, an element of the 22d Cavalry Division

Redesignated 1 November 1940 as Troop D, 107th Cavalry (107th Cavalry concurrently relieved from assignment to the 22d Cavalry Division)

Inducted into Federal service 5 March 1941 at Cleveland

Reorganized and redesignated 1 January 1944 as Troop B, 107th Cavalry Reconnaissance Squadron, Mechanized

Inactivated 16 November 1945 at Camp Bowie, Texas

Expanded, reorganized, and Federally recognized 10 November 1947 in the Ohio National Guard at Cleveland as Headquarters and Service Troop and Troop A, 107th Mechanized Cavalry Reconnaissance Squadron (Troop A – hereafter separate lineage)

Headquarters and Service Troop, 107th Mechanized Cavalry Reconnaissance Squadron, reorganized and redesignated 15 September 1949 as Headquarters Company, 1st Battalion, 107th Armored Cavalry

Reorganized and redesignated 1 September 1959 as Headquarters and Headquarters Troop, 1st Reconnaissance Squadron, 107th Armored Cavalry

ANNEX 3

Organized and Federally recognized 14 November 1947 in the Ohio National Guard at Willoughby as Company C, 112th Engineer Combat Battalion, an element of the 37th Infantry Division

Ordered into active Federal service 15 January 1952 at Willoughby

Redesignated 20 May 1953 as Company C, 112th Engineer Battalion

(Company C, 112th Engineer Battalion [NGUS], organized and Federally recognized 23 February 1954 at Willoughby)

237th SUPPORT BATTALION (NINTH OHIO)

Released from active Federal service 15 June 1954 and reverted to state control; Federal recognition concurrently withdrawn from Company C, 112th Engineer Battalion (NGUS)

Consolidated 15 August 1962 with Battery D, 1st Missile Battalion, 137th Artillery (see ANNEX 5), and consolidated unit designated as Company C, 112th Engineer Battalion

Redesignated 1 April 1963 as Company E, 112th Engineer Battalion

Reorganized and redesignated 15 February 1968 as the 194th Engineer Company and relieved from assignment to the 37th Infantry Division

ANNEX 4

Organized and Federally recognized 19 September 1949 in the Ohio Army National Guard at Cleveland as the Service Company, 107th Armored Cavalry

Reorganized and redesignated 1 September 1959 as Troop C, 1st Squadron, 107th Armored Cavalry

Consolidated 15 February 1968 with Company C, 2d Battalion, 137th Armor (see ANNEX 6), and consolidated unit designated as Troop C, 1st Squadron, 107th Armored Cavalry; location concurrently changed to Chagrin Falls

Converted and redesignated 1 May 1977 as Detachment 1, 155th Maintenance Company

ANNEX 5

Organized and Federally recognized 20 January 1953 in the Ohio Army National Guard at Willoughby as Battery D, 179th Antiaircraft Artillery Battalion

Reorganized and redesignated 1 December 1958 as Battery D, 179th Missile Battalion

Reorganized and redesignated 1 September 1959 as Battery D, 1st Missile Battalion, 137th Artillery

ANNEX 6

Organized and Federally recognized 9 November 1953 in the Ohio Army National Guard at Chagrin Falls as Company G, 107th Armored Cavalry

237th SUPPORT BATTALION (NINTH OHIO)

Consolidated 28 January 1955 with the 3641st Ordnance Company (see ANNEX 7), and consolidated unit designated as Company G, 107th Armored Cavalry

Reorganized and redesignated 12 October 1955 as Company D, 137th Tank Battalion, and assigned to the 37th Infantry Division

Reorganized and redesignated 1 September 1959 as Company D, 1st Medium Tank Battalion, 137th Armor

Reorganized and redesignated 1 April 1963 as Company C, 2d Battalion, 137th Armor

ANNEX 7

Constituted 27 January 1945 in the Army of the United States as the 244th Ordnance Medium Automotive Maintenance Company

Activated 13 February 1945 in France

Inactivated 1 December 1945 in Germany

Redesignated 14 August 1946 as the 3641st Ordnance Medium Automotive Maintenance Company and allotted to the Ohio National Guard

Organized and Federally recognized 4 March 1948 at Chagrin Falls

Ordered into active Federal service 11 September 1950

Reorganized and redesignated 23 October 1952 as the 3641st Ordnance Company

Released 28 January 1955 from active Federal service and reverted to state control
