**1136th TRANSPORTATION COMPANY**

Organized 10 July 1884 in the Maine Volunteer Militia at Brunswick as the 2d Platoon, 1st Battery, Light Artillery

Converted, reorganized, and redesignated 26 June 1890 as the 2d Regiment Gun Company

(Maine Volunteer Militia redesignated 28 March 1893 as the Maine National Guard)

Redesignated 6 November 1893 as Company K, 1st Infantry Regiment

Mustered into Federal service 13 May 1898 at Augusta as Company K, 1st Maine Volunteer Infantry; mustered out of Federal service 10 November 1898 at Brunswick and resumed state status as Company K, 1st Infantry Regiment

Converted, reorganized, and redesignated 1 January 1910 as the 10th Company, Coast Artillery Corps

Disbanded 17 November 1911 at Brunswick

Reconstituted 23 April 1912 in the Maine National Guard as the 10th Company, Coast Artillery Corps, and organized at Brunswick

Called into Federal service 25 July 1917; drafted into Federal service 5 August 1917

Reorganized and redesignated 11 August 1917 as the 4th Company, Fort Preble [Maine]

Redesignated 31 August 1917 as the 21st Company, Coast Defenses of Portland

## **1136th TRANSPORTATION COMPANY**

Demobilized in January 1919 at Portland

Reorganized and Federally recognized 28 March 1922 in the Maine National Guard at Brunswick as the 307th Company, 1st Coast Defense Command, Coast Artillery Corps

Reorganized and redesignated 17 September 1923 as Battery C, 240th Artillery (Coast Artillery Corps)

Redesignated 16 April 1924 as Battery C, 240th Coast Artillery

Redesignated 1 January 1931 as Battery G, 240th Coast Artillery

Inducted into Federal service 16 September 1940 at Brunswick

Reorganized and redesignated 7 October 1944 as Battery C, 186th Coast Artillery Battalion

Inactivated 1 April 1945 at Long Island, Maine

Reorganized and Federally recognized 16 May 1947 in the Maine National Guard at Brunswick as Battery C, 703d Antiaircraft Artillery Gun Battalion

Ordered into active Federal service 14 August 1950 at Brunswick; released from active Federal service 13 April 1952 at Brunswick and reverted to state control

Redesignated 1 October 1953 as Battery C, 703d Antiaircraft Artillery Battalion

Converted, reorganized, and redesignated 1 March 1959 as Troop M, 3d Reconnaissance Squadron, 103d Armored Cavalry

Reorganized and redesignated 1 June 1961 as Company A, 3d Medium Tank Battalion, 20th Armor

Redesignated 1 March 1964 as Company B, 3d Battalion, 20th Armor

Converted, reorganized, and redesignated 31 December 1967 as the Light/Medium Truck Platoon, 1136th Transportation Company

Redesignated 1 February 1972 as Detachment 2, 1136th Transportation Company

## 1136th TRANSPORTATION COMPANY

Reorganized and redesignated 1 November 1974 as the 1136th Transportation Company

Location changed 1 September 1993 to Bangor

Ordered into active Federal service 10 February 2003 at Bangor; released from active Federal service 14 June 2004 and reverted to state control

Ordered into active Federal service 11 March 2010 at Bangor; released from active Federal service 14 April 2011 and reverted to state control

HOME STATION: Bangor (less detachments at Sanford and Calais)


